Boarding Policies

- We encourage owners to bring their dogs own bedding and toys that they are familiar to them.
- We highly recommend bringing your dogs own food to ensure consistency of diet.
- Happy Dog Ranch, LLC is not responsible for loss or damage of any personal items.
- Pets may be roomed together if specifically requested, as long as the owner understands the risks involved: The added stress of being boarded may increase and cause otherwise friendly companions to fight.
- Dogs will not be accepted for boarding if they are too aggressive for our staff to handle safely.
- Dogs must be current on their vaccinations. Proof of vaccinations is required at check-in or boarding will be refused. Dogs must be current on Rabies, DHPP, and Bordetella.

Liability Waiver

I, _____, hereby certify that my dog, _____

Is in good health and has/have not been ill with any communicable condition in the last 14 days. I have read and understand the following:

1. I understand and agree, that in the event of an emergency, Happy Dog Ranch, LLC will first attempt to contact the owner, seconded by an attempt to contact the emergency contact of record, then the veterinarian of record, or an emergency veterinarian if it is determined that immediate treatment is necessary. Happy Dog Ranch, LLC maintain sole discretion, without liability, in emergency matters. I agree to pay for all medical treatments received, including transportation to a veterinary facility, promptly upon picking up my dog. I hereby agree to reimburse Happy Dog Ranch, LLC for veterinary costs, whether specifically authorized or not, in an amount which will be unlimited.
2. For senior and chronically sick pets: I understand that there are inherent risks in boarding a senior or chronically sick pet. Underlying health problems can be exacerbated by stress, and illness or infections, which would be minor in a healthy pet, but can become serious and even life threatening in an elderly or frail pet.
3. I understand and agree that Happy Dog Ranch, LLC and its staff will not be held liable for any problems that develop (e.g. injuries, fleas, ticks, and illnesses) during my pet's stay at Happy Dog Ranch, LLC.
4. I release Happy Dog Ranch, LLC of and from any and all responsibility for releasing my pet to any person to be authorized by myself.
5. Happy Dog Ranch, LLC shall exercise reasonable care of your pet while boarding. It is agreed by the owner that Happy Dog Ranch, LLC's liability in no event exceed sum of \$200.00 per animal boarded.
6. Storm Disclaimer: In case of storm, Happy Dog Ranch, LLC cannot guarantee the safety of owners' pets. Happy Dog Ranch, LLC agrees to make every effort possible, without endangering kennel staff, to care for animals entrusted to us. It should be understood by owner that should conditions warrant we too may be forced to evacuate premises. Owner agrees not to hold Happy Dog Ranch, LLC responsible for injury or loss of pet due to above mentioned fact.
7. This contract contains entire agreement between parties. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representatives of the pet owner and Happy Dog Ranch, LLC.
8. I further understand that if my dog is left at Happy Dog Ranch, LLC for a period of 48 hours beyond the agreed pickup date, without contact from the owner, this dog will be considered abandoned and necessary steps will be taken to turn the dog over to the proper authorities or to place the pet in another home.

I certify that I have read and understand the policies and boarding guidelines of Happy Dog Ranch, LLC as set forth on the preceding page and that I have read and understand the conditions and statements of this agreement.
